Electric Cooperative has meeting

NEW CONCORD - The Guernsey-Muskingum Electric Cooperative recently held its 81st annual member meeting at Larry Miller Intermediate School in New Concord.

Incumbents Brian Hill and John Enos were re-elected to the board of trustees to represent District 1 and 4, respectively. Jeff German, with 31 years of service, and Beth Motta, with 26 years of services, retired as trustees in the past year and were recognized for their service.
