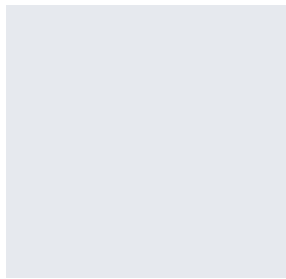

LEP - Educational Psychologists (California) National Certified School Psychologist (NCSP)	Educational Psychologists (LEP) in California are licensed through the California Board of Behavioral Sciences. <p>Nursing: RNs, LVNs, Psychiatric Technicians and CNAs.</p> <p>Hospice and Palliative Care Nurses: ACHPN®, CHPN®, CHPNA®, CHPLN®, CHPPN®, CPLC and CHPCA®</p>	<p>All courses are approved by the California Board of Registered Nursing and the California Board of Licensed Vocational Nursing and California Board of Psychiatric Technicians.</p> <p>Quantum courses are accepted for approval for Hospice and Palliative Care Nurse recertification by HPNA due to our approval with the California Board of Registered Nursing.</p> <p>Courses under the Nursing Category only are approved by the District of Columbia Board of Nursing, the Florida Board of Nursing and Florida Board of Certified Nursing. RCFE, ARF and Professional Fiduciaries	Our courses under the Assisted Living and Elderly Care category are approved by the California Dept. of Public Health and Dept. of Social Services by virtue of our approval by the Calif. Board of Registered Nursing.
Social Workers	All CE Courses are approved by the California Board of Behavioral Sciences which licenses Social Workers, the Florida board for Social Workers and the Texas Board of Social Workers. Many state boards will accept these
