Facilitation technique/modality: Personal Training

# Requirements:

- You must be at least 18 years of age.
- You must hold current adult CPR and AED certificate at the time of the exam.
- Successfully pass the ACE Personal Trainer exam

# **Length of Training:**

Training for the ACE Personal Trainer exam is completed on an individual's personal time. Depending on how dedicated and motivated an individual is, the length of time to prepare for the exam may differ.

#### Where:

Some colleges offer courses that prepare an individual for the ACE Personal Trainer exam. There are numerous useful study guides, exam reviews, and online practice exams to help in preparation for the exam. The exam is administered in a proctored setting either online or in a written format which can be taken at various locations throughout each state.

# **American Canoe Association Instructor**

**Facilitation technique/modality:** Adventure Therapy

<u>Instructor:</u> ACA Instructors are expected to represent and promote the ACA and paddle sports in a positive manner. ACA Instructors do not issue certificates or certify basic skills, but may issue participation cards to students.

# **Requirements:**

- Instructors shall be at least 18 years of age
- Maintain ACA Membership and SEIC dues
- Participate in an Instructor Development Workshop (IDW) and pass an Instructor Certification Exam (ICE). These courses are offered either as separate courses with time between for skills and presentation development and practice, or can be offered concurrently (at the discretion of the Instructor Trainer) as an Instructor Certification Workshop (ICW).
- Perform paddling skills with demonstration quality
- Demonstrate effective teaching skills
- Demonstrate technical knowledge of paddle sport
- Demonstrate appropriate safety & rescue ability
- Demonstrate group / course management and interpersonal skills

Certification Areas: Canoe Touring; River Canoeing; Coastal Kayaking; River Kayaking; Surf Kayaking; Rafting; Safety and Rescue; Adaptive Paddling\

# **Length of Training:**

ACA Instructor—self-paced 16+ hours training

## **Instructor Trainers**

# **Requirements:**

- be at least 21 years of age
- maintain ACA and SEIC membership
- be an active ACA Instructor for at least two years\*
- Instructor Trainer paddling and teaching skills and knowledge shall be of advanced level.
- Participate in an ITDW or co-teach an IDW/ICE
- Verify with the ACA National Office their eligibility as an IT Candidate prior to leading an IDW/ICE under the direct supervision of an ITE.
- Satisfactorily lead an IDW and ICE with assistance and direct oversight by an ITE.

- IT Educator shall submit an official IT Recommendation Form within 30 days of the ICE completion. Two additional ACA Instructor or Trainer nominating signatures are required.
- Final certification approved by the SEIC Standards Committee.

# **Length of Training:**

Instructor Trainer—2+ years 40+ hours training

## **Instructor Trainer Educators**

**Requirements**: It is expected that Instructor Trainer Educator paddling and teaching skills and knowledge shall be of significantly advanced level. Additionally:

- Two years experience as Instructor Trainer
- Attend any ACA instructional clinic conducted by an IT in another discipline or Division or submit written rationale for exception
- Submitting the ITE Application Form with resume and three letters of recommendation, one from an ITE within the same discipline at the level of desired certification.
- Submit videotape modeling of paddling and teaching skills, or arrange an in-person review
- Submit IDW/ICE course outlines and evaluations.
- The decision to designate applicants as an ITE is at the discretion of the Standards Committee and shall be approved by the SEIC with applications reviewed periodically.
- The ITE endorsement is valid for four years, after which, the ITE must reapply, the SEIC determining if the ITE has fulfilled the duties as defined.

# **Anger Management Specialist**

# (National Anger Management Association)

Facilitation Technique/ Modality: Anger Management

Anger Management Specialist I— Certifies individual to provide anger management educational services including Anger Management Classes and Anger Management Educational Programs for individuals may be court mandated. The Anger Management Specialist I may provide anger management counseling/therapy under the supervision of an approved supervisor and with the intention of qualifying for the Anger Management Specialist II certification.

## **Requirements:**

Minimum Bachelor's Degree

1. Basic Anger Management Content Component

Completion of a Basic Anger Management Content program sponsored by or approved by NAMA. The program include (at minimum) an overview of anger problems, an understanding of the nature of anger, anger management skills & concepts, utilization of anger log and the role of trigger thoughts, an understanding of primitive/evolved brain functioning, cognitive distortion, the role of communication and assertiveness, role of empathy and perspective, role of stress, and the role of consequences.

# 2. Supervision Component

Completion of a minimum of 4 sessions of anger management supervision with a NAMA approved supervisor. This supervision can be arranged by appointment in person, by telephone, or by electronic mail. A fee for Supervision will be charged beyond the cost of the Basic Content.

3. Application Component

Complete Application and provide resume for NAMA Review.

<u>Anger Management Specialist II</u>—Certifies individual to provide anger management clinical services including anger management counseling, anger management therapy in accordance with their particular mental health license.

1. Anger Management Cases Component

Completion (at minimum) of 40 hours of Anger Management cases hours as an Anger Management Specialist-I and at least 6 months of anger management individual or group facilitation.

2. Supervision Component

Completion of a minimum of 4 supervised anger management sessions with a NAMA approved supervisor. The supervision can be completed in person or by telephone. The fee for Supervision will be determined by your approved supervisor and yourself.

3. Application Component

Complete Application and provide proof of Anger Management Specialist I Certification or equivalent, professional mental health state license, and professional liability insurance for NAMA Review.

- Minimum of Anger Management Specialist I Certification or equivalent
- Professional mental health state license
- Professional liability insurance

The philosophy statement and case study should include (at minimum) a continued understanding of anger problems from various mental health perspectives, advanced anger management skills & concepts, an advanced understanding of brain functioning in anger management, an advanced knowledge of communication and assertiveness issues, an advanced understanding of the role of empathy and perspective taking, an advanced understanding of stress management, and the role of consciousness and awareness in anger management. The Philosophy Statement and

Case Study should also include specified goals, objectives, and supervision techniques to be used in the supervision component of anger management certification training.

Completion of two 'Defense of Statement and Case Study' interviews (45 min. each) with 2 different NAMA approved anger management supervision providers. A fee for each interview will be charged.

# **Animal Assisted Therapy**

Facilitation technique/modality: Animal Assisted Therapy

**Credential:** Registered Pet Partner

# Requirements:

Prerequisites for the Human Partner HAVING YOUR OWN PET IS NOT NECESSARY.

Age 16 or older

Complete the course in one of the 2 formats offered:

- Attend a workshop: The Pet Partners Team Training Course is usually presented as a 12-hour hands-on course. Students receive a copy of the popular Pet Partners Team Training Course Manual and practice visiting skills. <u>Courses are</u> <u>scheduled</u> throughout the year in locations all over the country. All workshops are taught by Delta-licensed instructors. To find a Pet Partners Team Training Course near you, click HERE.
- Complete the home study course: For handlers who cannot attend a workshop, Delta offers a <u>home study version of the Pet Partners Team Training Course</u>.
   The course includes a student guide with suggestions for activities that will help handlers learn the necessary skills and registration materials.

## Team Evaluation:

- Pet Partners Skills Test (PPST) will show whether the animal can be controlled by the handler and follow basic commands. During the PPST, you will be assessed on how you interact with the evaluator, the evaluator's assistants, the animal, and the environment around you.
- Pet Partners Aptitude Test (PPAT) is designed to simulate conditions you may encounter on a visit. This screening helps determine the most appropriate environment for you and your animal to visit. During the PPAT, you will be assessed on how well you interact with the evaluator and evaluator's assistants as you simulate being on a visit. They will be role-playing as though they are in a facility. Your interactions may be in the form of questions, responses to the evaluator and evaluator's comments, eye contact, smiling, head nodding, directing the animal to interact, or other verbal and nonverbal methods of communicating.

#### Other:

Eligible Species: There are a great many species that make wonderful visiting animals and can form a strong human-animal bond. Only domesticated animals may become Pet Partners. Examples of registered pets include: Dogs, Cats, Guinea Pigs, Rabbits, Domesticated Rats, Horses, Goats, Llamas, Donkeys, Potbellied Pigs, Miniature Pigs, Cockatoos, African Gray Parrots, Chickens.

Species NOT Eligible: Wild or exotic animals (e.g., snakes, ferrets, lizards) may not be Pet Partners.

*Birds*: Must have lived in the owner's home for at least 1 year.

"Pocket Pets": (e.g., guinea pigs, rabbits, rats, etc.)

Must be at least 6 months at the time the animal is evaluated

All other animals: Must have lived in the owner's home for at least 6 months. Must be at least 1 year at the time the animal is evaluated.

<u>NOTE:</u> Dogs that have been trained to aggressively protect and/or have been encouraged to bite, even if it is a component of a dog sport (e.g., bite work that is part of Schutzhund) may not be Pet Partners.

# **Aquatic Therapy**

Facilitation technique/modality: Aquatic Therapy

**Requirements**: Pass exam

- The examination tests the six basic Standards of the Aquatic Therapy and Rehabilitation Industry
  - o Movement Mechanics and Science which make up 21% of the exam.
  - o Aquatic Principles which make up 22% of the exam.
  - Aquatic Therapy Principles and Methods which make up 31% of the exam.
  - o Professional Responsibility which make up 14% of the exam.
  - Health and Safety which make up 14% of the exam.
  - Legal Considerations which make up 4% of the exam.
- Prerequisite. The prerequisite for this exam is 15 hours of Aquatic Therapy, Rehab and/or Aquatic Therapeutic Exercise education. It is preferable that the education is hands-on but online or correspondence courses also qualify.

Length of Training: 15 hour prerequisite listed above and exam time

**Cost:** The fee to sit for the *onsite* exam is \$255. The fee to take the exam online is \$255. The retake fee for the exam is \$95.

#### Other:

 Certification Renewal. ATRI certification is valid for one year. To maintain your ATRI certification, you must obtain a minimum of 10 Continuing Education hours within the next year. Any excess of continuing education credits can be carried over for the next year's renewal. Therefore, if you go to a conference this year to meet your 10-hour renewal requirements and get 20 credit hours you can use them for this year and next year's renewal.

# **Aromatherapy**

Facilitation Technique/ Modality: Aromatherapy

 The use of volatile plant oils, including essential oils, for psychological and physical wellbeing

# **Requirements:**

- Any topical application of essential oils would require one to have a professional license-example; massage therapy
- Depending on the state that you reside and offer your services in, you would need to contact the state board of the particular profession for more information
- As with any licensed profession it is the responsibility of the practitioner to abide
  by their professions code of ethics and to be aware of their professions state
  laws regarding regulation and licensure and to abide by their scope of practice

Level One: Foundations (30 hours)

Curriculum: Introduction to Aromahistory-focus on ancient cultures, Profiles of 10-20 essential oils, Production and Quality of Essential Oils, Basic Physiology-Methods of absorption, general overview of limbic system, lymphatic system, immune system, and skin, How oils interact on physical and emotional levels, Basic aromachemistry with contraindications of certain oils, How to create a blend, carrier oils, and various methods of application.

Level Two: Professional Aromatherapy Certification

Required Standards of Education/Training (minimum of 200 hours) to consist of training and practical tuition in fields of aromatherapy and essential oil studies and anatomy and physiology, including in-depth coverage of:

- The Respiratory system and the Integumentary system, and the olfactory process.
- Basic anatomy and physiology of the following systems: The Reproductive, Circulatory, Nervous, Endocrine, Lymphatic/Immune, Urinary, Musculoskeletal and Digestive.
- Graduating students should be knowledgeable in the structure and function of all the major systems of the human body, together with the clinical science of at least five (5) common ailments of each.
- Students entering an aromatherapy program with a degree in health related fields (e.g. Nurses, Massage therapists, Doctors) may test out or be exempt from the anatomy and physiology section only in relation to that part of the training which goes over the structure and function of each system. Pre-existing health professionals are still required

to complete training in the application of essential oils to each system and the effect of essential oils on a variety of common ailments.

 Any exemption of the anatomy and physiology portion of training should only be allowed when the request for exemption is fully supported by relevant documentation

## **Biofeedback**

Facilitation technique/modality: Biofeedback

**Credential:** General Biofeedback Certification

# Requirements:

<u>Prerequisite education</u>: Candidates are required to hold a bachelor degree or higher from a regionally accredited academic institution, in a BCIA (Biofeedback Certification Institution of America) approved health care field.(Recreational therapy is approved, but a signed, sealed, original transcript from the university that granted your highest degree must be submitted directly to BCIA.)

 Human Anatomy/Physiology Course- A comprehensive course in human anatomy, human biology, or human physiology from a BCIA accredited program or a regionally accredited academic institution (three semesterhours or its equivalent) fulfills this requirement. Appropriate courses are also available through distance education.

<u>Didactic Biofeedback Education</u> - A 48 hour didactic education program specifically covering all topics as listed in the BCIA Blueprint of Knowledge taken from either a (1)regionally accredited academic institution or a (2)BCIA accredited training program. Note: If course work in Instrumentation or Professional Conduct was taken through a prior accredited didactic workshop for a different BCIA certification, these topics will not have to be repeated.

<u>Practical Biofeedback Training</u> - 20 contact hours with a BCIA approved mentor. The 20 contact are used hours to review:

10 sessions of personal biofeedback, demonstrating self-regulation.

50 sessions of patient/client treatment as follows: 10 sessions each of Thermal.

EMG and GSR. The remaining 20 sessions are to include any combination of EMG, Thermal, GSR, EEG, HRV, and respiration training.

10 case conference presentations.

\*Sessions are a minimum of 20 minutes.

<u>License/Credential for Independent Practice:</u> When treating a medical or psychological disorder, you are required to hold a current health care license or agree to work under the supervision of an appropriately credentialed health care professional. This credential in a BCIA approved health care field must be issued or recognized by the state in which you practice.

<u>Written Examination:</u> A three-hour objective examination covering the Blueprint areas is required of all candidates. Examinations are offered throughout the year in various locations or by special exam arranged at a university testing center with a proctor.

<u>Sequence for Meeting Certification Requirements:</u> An individual becomes a candidate for certification by submitting an application with documentation of the educational prerequisite and payment of a filing fee. BCIA recommends, but does not require, that candidates complete the remaining requirements in the order: 1) anatomy/physiology course, 2) didactic biofeedback education, 3) mentored clinical biofeedback training, and 4) written exam.

# **Certified First Responder**

# Facilitation technique/modality: Certified First Responder

- A person providing pre-hospital care for medical emergencies
- More skill than someone who is trained in basic first aid, but they are not emergency medical technicians
- Certified first responders fill the gap between a basic first aid provider and an EMT-Basic

# Requirements:

- Students with a high school diploma can enroll in a college's emergency medical technology program to prepare for a career as a First Responder
- Program requirements vary by state, but typically include courses covering emergencies as varied as vehicle crashes, heart attacks, drowning, childbirths, gunshot wounds, strokes, falls, diabetic emergencies and environmental exposures. Courses usually include a practicum.
- The certified first responder course curriculum is divided into seven modules: preparatory, airway, patient assessment, circulation, illness and injury, childbirth and children and Emergency Medical Services operations. Within these modules, students receive training in patient assessment, bleeding and soft tissue injuries, circulation and legal and ethical issues, among others
- One must pass both state exams to become an emergency medical technician First Responder; national certification is also available. This includes the relevant National Registry Examination for national and statewide certification for EMTs.

# **Length of Training:**

• Certified first responder training programs involve a 60-hour training program

#### Where:

- A certified first responder can also recognize and treat cases of poisoning, shock and heart attacks.

**Certification:** Certified Parks and Recreation Professional

# Requirements:

The standards for the Certified Park and Recreation Professional (CPRP) are as follows. The CPRP applicant must:

- Hold a bachelor's degree from an NRPA accredited program, verified by official transcript, and pass the CPRP examination; OR
- Hold a bachelor's or higher degree from a regionally accredited education institution (from a non-NRPA accredited program), verified by official transcript, with a major in recreation, park resources, or leisure services; have no less than 1 year of full-time experience in a recreation, park resources, or leisure service position that encompasses each domain of the job analysis following the degree; and successfully pass the CPRP examination; OR
- Hold a bachelor's or higher degree from a regionally accredited education institution, verified by official transcript, with a major other than recreation, park resources, or leisure services; have no less than 3 years of full-time experience in a recreation, park resources, and leisure position that encompasses each domain of the job analysis following the degree; and successfully pass the CPRP examination; OR
- Hold a high school diploma, equivalency certificate, or associate's degree from a
  regionally accredited institution, verified by official transcript/documentation; have
  no less than 5 years of full-time experience in a recreation, park resources, or
  leisure services position that encompasses each domain of the job analysis
  following the diploma/degree; and successfully pass the CPRP examination.
- Students who have not yet graduated from an NRPA accredited program may be able to qualify for exam status. They may complete the CPRP exam prior to the completion of the internship requirement and academic degree attainment.
- The CPRP must apply for and pass the certification exam.

## **Length of Training:**

There is no specific training but you can prepare for the examination by using one of NRPA's three resources:

- The Official Study Guide for the CPRP Examination. The cost is \$34 for NRPA members and \$47 for non-members, plus shipping & handling.
- An online practice exam costs \$55 for NRPA members and \$65 for nonmembers.
- The CPRP Candidate Handbook provides a complete detailed content outline for the exam, including a list of recommended texts for each section. The Handbook is free.

- You can substitute .5 CEUs for Professional Experience Points
- You can petition for CEU equivalency

# **Certified Substance Abuse Counselor**

# (North Carolina Substance Abuse Professional Practice Board)

# Requirements:

Step 1: Register

To register and begin the certification process, the applicant must send the following to the Board:

- 1. The completed registration form found in the registration application package;
- 2. Documentation of high school graduation, completion of GED, Baccalaureate or advanced degree.
  - (Use transcripts as documentation as appropriate).
- 3. A signed supervision contract documenting the proposed supervision process by either a CCS or a CCS Intern.
- 4. A signed form attesting to the applicant's commitment to adhere to the Ethical Principles of Conduct of the Board (Verification Statements).
- 5. A check or money order in the amount of \$125.00 (non-refundable) made payable to NCSAPPB.

Once the above is received by the Board, the applicant's materials will be reviewed. If found to be in order, the applicant will be granted registration status.

Step 2: Substance Abuse Counselor Intern

To be recognized as a Substance Abuse Counselor Intern, a counselor must submit and successfully complete the following:

- 1. Completed registration form found in the registration/application package.
- 2. Documentation of high school graduation, completion of GED, Baccalaureate or advanced degree.
  - (Use transcript as documentation where appropriate).
- 3. A signed form attesting to applicant's commitment to adhere to the Ethical Principles of Conduct of the Board.
- 4. A signed supervision contract documenting the continuing supervision process by a CCS or CCS intern.
- 5. Documentation verifying the successful completion of 300 hours of Supervised Practical Training.

## Step 3: Certified Substance Abuse Counselor

The following is a review of the requirements for certification as a Certified Substance Abuse Counselor:

- 1. The equivalent of three (3) years full time paid or volunteer supervised experience (6,000 hours) obtained as defined above. Experience must also be obtained in a setting, program or facility whose function is treating alcohol and drug abuse. If a work setting is not exclusively substance abuse focused, the applicant may accumulate experience proportional to the direct or indirect substance abuse services they perform. For example, with a 75% substance abuse counseling caseload, the applicant would need 4.5 years experience, with a 50% substance abuse caseload, the applicant would need 6 years experience.
- 2. 270 clock hours of Board approved education/training in the following ratio: 190 hours substance abuse specific (SAS), and up to 80 hours may be directed toward general skill building (GSB). No more than 25% of the 270 hours (67.5 hours) may be in-service education received within your organization by staff of the same employment. All applicants for certification as a Substance Abuse Professional must document twelve (12) hours HIV/AIDS training/education and six (6) hours professional ethics training/education.
- 3. A \$125.00 written exam fee and \$125.00 registration fee (non-refundable), if not already paid previously.
- 4. Completed evaluation forms must be submitted by three (3) references: Supervisor, Co-Worker, and Colleague. These evaluations must be mailed directly to the Board by the individuals completing the forms.
- 5. Successful completion of the written examination (\$125.00 written exam fee plus \$125.00 registration fee, non-refundable, if not already registered with the Board).

Upon successful completion of the examination a Certified Substance Abuse Counselor certificate and number will be awarded.

- Minimum, 7 hour NCCDP Comprehensive Dementia Curriculum taught by an approved NCCDP Certified Instructor
- Two year renewable certification

- Reflexology has anecdotally been found to have a positive effect on the body suffering from a wide variety of chronic problems
- Reflexology is not a substitute for medical treatment, but should be used as a complement to any type of medical approach or therapy
- Reflexology can also be incorporated into an overall healthy lifestyle

## Requirements:

- ARCB (American Reflexology Certification Board) is of the opinion that Reflexology is a hands-on discipline requiring hands-on instruction
- One of the prerequisites for testing with ARCB is completion of a 'hands-on' Reflexology course involving a minimum of 110 hours (home-study or correspondence type of Reflexology courses would not provide this 'hands-on' training, making you ineligible to test with ARCB)

# **Length of Training:**

Reflexology programs generally take between six and twelve months to complete and involve 150 to 300 hours of study combined with hands-on practice.

#### Cost:

- You can expect tuition for a reflexology program to be approximately \$1,500 to \$3,500
- As part of your education, you will also need to purchase a massage table or reclining chair, which typically costs \$200 to \$500
- In order to remain in good standing with the certification board, a certified
  practitioner of reflexology must pay an annual fee every year (\$55) and obtain
  12 hours of continuing education (CE) every two years from the date of his/her
  initial certification date with ARCB.

#### Other:

- Certification requirements for reflexologists vary from state to state. Many reflexology school programs result in reflexology certification that meets state requirements; however, others may deliver a diploma without certification.
- You will need to research the laws for the state where you plan to practice to ensure that you make the best choice in a reflexology school program.

- Must submit Verification and Breakdown of Supervisory Hours one per supervisor.
- Must submit Evaluation and Documentation (One per ADTR Supervisor)
- Must submit Employment Verification Form for each place of employment.
- Must sign Code of Ethical Practice completed and signed by a Notary Public.

# **Registered Arts Therapist**

Facilitation Technique/Modality: Registered Art Therapist

**Requirements:** Three Options

<u>Option A</u> is for applicants who graduated from a master's degree program approved by AATA at the time of graduation.

Education Required

Applicants must provide an official transcript verifying a master's degree from an AATA-approved program.

Post-education Experience Required

Applicants must have:

- A minimum of 1,000 hours of supervised direct client contact using art therapy.
   (Hours used to complete administrative tasks cannot be included for the purpose of obtaining the ATR.)
- A minimum of 100 hours of supervision

<u>Option B</u> is for applicants who graduated from a master's degree program  $\underline{NOT}$  approved by AATA at the time of graduation.

Education Required

Option B applicants must provide official transcripts that document completion of:

- A master's degree in art therapy or a related field from a program not approved by AATA at the time of applicant's graduation.
- A minimum of 24 graduate semester credits (or 34 quarter credits) in art therapy core curriculum (not including credits earned for practicum/internship)
- A minimum of 700 hours of supervised art therapy practicum/internship
- 15 semester credits\* (or 22 quarter credits) in studio art.
- 12 semester credits (or 18 quarter credits) in psychology (including abnormal and developmental psychology). These may be undergraduate or graduate level courses.

Post-education Experience Required

Applicants must have:

- A minimum of 1,500 hours of supervised direct client contact hours using art therapy.
- A minimum of 150 hours of supervision.

<u>Option C</u> is for applicants who have completed a master's degree in a related discipline and post-master's study in art therapy that did not lead to a master's degree (e.g., a post-master's certificate program).

Education Required

Option C applicants must have:

- A master's degree in art therapy or a related field.
- A minimum of 24 graduate semester credits (or 34 quarter credits) in art therapy core curriculum (not including credits earned for practicum/internship).

- A minimum of 700 hours of supervised art therapy practicum/internship, including a minimum of 350 hours of direct provision of art therapy services to individuals, groups, and/or families.
- 15 semester credits (or 22 quarter credits) in studio art. These may be undergraduate or graduate level courses.
- 12 semester credits (or 18 quarter credits) in psychology (including abnormal and developmental psychology).

These may be undergraduate or graduate level courses.

Post-education Experience Required

Applicants under Option C must provide Verification of Post-education Experience Form(s) documenting:

- A minimum of 1,500 hours of supervised direct client contact hours using art therapy.
- A minimum of 150 hours of supervision. At least 75 of the hours must be supervised by a current ATR or ATR-BC.

For all options, applicants must submit three (3) Reference forms and supporting letters from:

- At least one (1) current ATR or ATR-BC
- An applicant's supervisor who possesses a credential or state license
- A professional who can provide a reference pertaining to the applicant's work performance and art therapy skills.

Facilitation Technique/Modality: Registered Dance Therapist

## Requirements:

Must complete and/or submit:

- A Master's degree in dance/movement therapy or a related field (such as counseling or social work)
- All required dance/movement therapy training courses and required counseling/psychology courses and listed them properly on the application form
- A minimum of five (5) years of concentrated study in dance
- A 200 hour fieldwork requirement
- A 700 hour internship supervised overall by an ADTR
- A catalogue descriptions for all coursework in quadruplet
- Letters of recommendation from two (2) ADTR's, or one (1) ADTR and one (1)
  Master-level (or above) mental health professional, who have seen your work
  within the last two years
- The ADTA Oath and had it signed by a Notary Public
- One (1) original and three (3) photocopies of your application to the National Office
- Must submit fieldwork and Internship Verification forms for each site
