A CDP certification reflects a deep personal commitment on the part of the front line staff, health care professional and the organization's sense of accountability by abiding by NCCDP the Ethic's statement, inspiring confidence and dedication in an individual's professional knowledge through quality of life and quality of care provided by the CDP to the dementia patient.
