Audioconference Special Rates for 2012!

Sign up for a full year and Members get 3 site fees FREE!

Sign up for six and take \$60 off total site fees!

The member rate for the full year is \$540 (\$1,080 for non-members), but *sign up now for all twelve*, you pay only \$405 for site fees (\$810 for non-members), and then \$10 per person (\$12 for non-members). You will save \$135 for members and \$270 for non-members. You pay the site fees up-front and then you'll be billed for individual participants only, after we receive your roster. There's no need to register for each audioconference, just complete the roster and evaluations after the session!

Select the six month package, you'll get to choose the six in which you wish to participate, and you can take \$60 off the total site fees! At the member rate, six audio conferences would be \$270 (\$540 for non-members), but if you sign up now for the *six conference package*, you will pay only \$210 (\$410 for non-members), plus the \$10 per person (\$12 for non-members). You'll be billed after the audio conference when we receive the roster. All you need do is register now for the package, and then register individually for the audioconferences you want. At the conclusion of these audioconferences you will be billed only for the per person fee for the rosters you return.

Site Registration: All you need to participate is a phone or speaker phone. A site coordinator from each participating agency must be registered using the form below. Materials such as the call instructions, roster, handouts, and evaluations will be sent to each site coordinator prior to the audioconference. It is the responsibility of each site coordinator to copy and distribute materials to the additional participants on the call. After the completion of the audioconference, the site coordinator is responsible for entering all participants on the on-line roster, and for providing participants with the on-line location for completing the evaluation for this course. Rosters and evaluations must be entered by Wednesday following the audioconference, or a \$35 late fee will be charged.
