

Dear Friends,

We have begun a New Year; and at Hebrew Health Care it is natural to think about what lies ahead for health care and aging services. Last September, the State budget was approved by the legislature. Governor Rell refused to sign or veto the budget, allowing it to become law without her signature. While the dust settles at the State Capitol, we continue to hear news reports about uneasy health care reform debates in Washington. Everyone, it seems, remains highly-focused on health care and all of the problems attendant on its quality, affordability, and accessibility.

Regardless of the outcome of the health care reform debate, the latest changes to existing systems like Medicare and Medicaid, or the vagaries of state budget decisions, Hebrew Health Care understands that our community looks to us to assure appropriate care and services for older adults. And we in turn look to all of our constituents to help us meet that mandate.

Hebrew Health Care finished our own fiscal year successfully. With unprecedented community support, especially in a strained economy, we met—and even modestly exceeded—our fundraising targets for the year. We received support from 100% of our Trustees in that effort. Once again we called on our staff to make concessions in wages, hours and benefits in order to reduce our spending to manageable levels. We reduced payroll and other expenses by significant levels and learned to live within the new constraints. Our goals were simple: preserve mission and preserve jobs—because without our talented and caring staff—we cannot possibly meet that first goal.

The last two years have been very challenging, but very rewarding, for our organization. We have moved forward important programs, like Hospice and our Hoffman SummerWood expansion, even while adjusting to reduced reimbursement and a regulatory environment which feels at once both quixotic and immovable. We know that it is not likely to be easier going forward; but we are encouraged by our successes: our ability to meet our budget; increasing community support; and unwavering employee commitment.

Thank you all for helping us realize those successes. We hope we can continue to count on each of you in the year ahead, and for many years to come.



Continued from Cover... During the Committee's first year, at least 8 new initiatives were implemented in and around our Abrahms Boulevard campus.

The Committee's most recent endeavor, an Energy Fair open to our community and the general public, was a day-long event offering a variety of informational exhibits. Fifteen local businesses exhibited conservation techniques and products.

Of special interest was a solar energy exhibit by resident James Minges, PE, LA, former owner of Solar Energy Systems. HHC's Resident Council also exhibited their new 'sticker system' initiative, which will reduce energy usage significantly by turning off televisions and lights in unoccupied rooms. Vincent DeSanti, Assistant Operations Officer and Committee Co-Chair, was available to provide information about HHC's upcoming co-generation project.

"The reason we opted to undertake this co-generation project is because it is environmentally friendly and cost effective," remarked DeSanti. "You basically need a natural gas fired car engine, which powers a generator that produces electricity and domestic hot water and heat. By doing so, we're reducing the demand on the electrical grid and using our boilers less, which means less wear and tear on them."


Special guests included Mayor Scott Slifka and Deputy Mayor Tim Brennan, who was available to talk about the Town of West Hartford's energy conservation efforts.

certified as a Qualified Dementia Care Provider

Every 70 seconds someone develops Alzheimer's Disease (AD). Currently 5.3 million Americans struggle with AD. Pamela Atwood, Hebrew Health Care's Director of Life Enrichment and Dementia Care, has focused her career on understanding the disease and helping others through education and support services.

In July, Ms. Atwood was named a Qualified Dementia Care Provider by the Alzheimer's Foundation of America. The QDCP status was awarded after completing a 4-part training program and certification exam. Ms. Atwood has also renewed her certification through the National Council of Certified Dementia Practitioners™.


Ms. Atwood has developed Hebrew Health Care's Elder Care Consultation Service, which is available to the general community, offering memory screenings, staging dementia, and information and referral for care options. She has been with Hebrew Health Care since 2002. Previously, she was the Director of Programs for the Northern Connecticut Chapter of the Alzheimer's Association.

APRNs work with the physicians and other employees on staff to provide medical care to patients. Several APRNs also teach Nurse Practitioner students from Yale University and University of Connecticut: yet another instance of Hebrew Health Care providing service for today and education for those who will care for the aged in the future.

We hope you'll stop by to meet him and tell him he's a 'pretty bird.' If you do, he just might answer you back!


