# 2nd Regular Session of the 50th Arizona State Legislature

Today marked the deadline for Senate bills to be heard in Senate Committees and House bills to be heard in their committees triggering considerable activity this week. Since February 9<sup>th</sup>, 972 floor actions were filed; 89 of those related to legislation tracked by the Council on Aging. (See **FULL LIST** link)

At the end of day 40 of the legislative session, 1,373 bills posted; 2 passed; 1 signed by the Governor, 140 memorials or resolutions posted; 8 passed. Several of the bills may be of interest to Arizona seniors and will be tracked by the Council and appear on the Legislative Update web page. Please be advised that the presence of a bill on the Council's tracking list does <u>not</u> represent support or opposition by the Council to that bill. It does mean that the bill topic is something that is likely to be of interest to or have an impact on Arizona seniors so the Council is tracking the bill's progress.

## H.R.3790

## **Improving Cancer Treatment Education Act of 2012**

Introduced on 1/18/2012 by Representative Steve Israel (NY-2)

H.R.3790 amends title XVIII of the Social Security Act to provide comprehensive cancer patient treatment education under the Medicare Program and to provide for research to improve cancer symptom management.

On 1/20/2012, H.R.3790 was referred to the House Subcommittee on Health.

## **Health Freedom for Seniors Act**

Introduced on 1/24/2012 by Representative Bill Huizenga (MI-2)

To amend the Internal Revenue Code of 1986 to allow the transfer of required minimum distributions from a retirement plan to health savings account.

On 1/24/2012, bill referred to the House Committee on Ways and Means.
