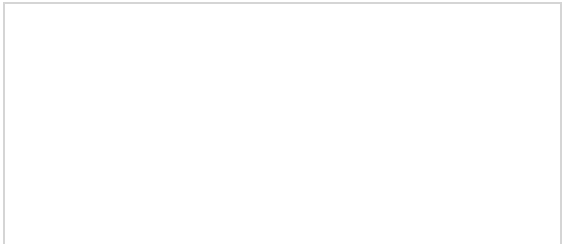
The winners will be honored at the 2014 American Health Care Association/NCAL convention in October.

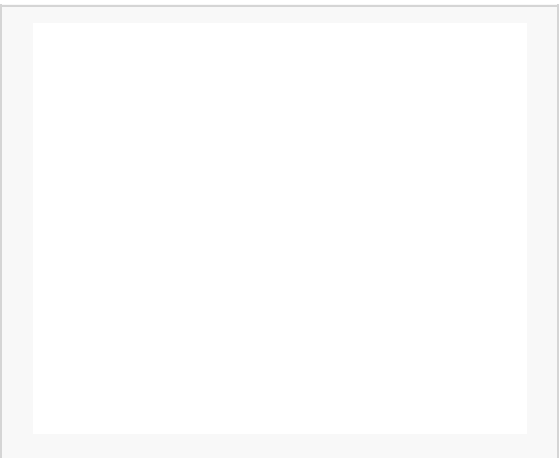
