

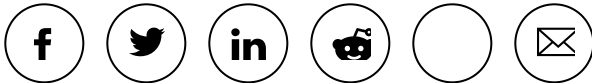

Twin Lakes executive director announces retirement from senior living career

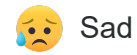
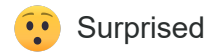
