*S-COPE's* mission is to address psycho-geriatric challenges and provide professional training and staff development to insure the appropriate use of acute psychiatric services and effective support of older adults with behavioral and psychiatric challenges.

*S-COPE* partners with New Jersey Institute for Successful Aging (NJISA) to provide state of the art clinical response throughout the state.

*S-COPE* is committed to promoting state-of-the-art geriatric behavioral health services within LTC through education, on-site training, workshops and annual conferences.

In addition to holding an annual conference, S-COPE provides 9 Regional Trainings per year in locations throughout the state. S-COPE clinicians also provide in-service trainings upon request.

# 9:30 am - 11:00 am: Delirium: Like A Bad Penny by Martin Forsberg, MD. Chief of Geriatric Behavioral Health at Rowan SOM

An overview and exploration of delirium related to older adults in LTC;

- Causes, risk factors and outcomes
- Using the Confusion assessment method for screening
- Barriers to effective identification and management

Dr. Forsberg serves as medical director and psychiatric consultant in long term care. His presentation includes an overview of delirium and its impact on morbidity and mortality.

## Participants will be able to:

- Identify the causes and risk factors for delirium in LTC (Name 3 risk factors for delirium)
- Use a standardized screening tool for delirium (Name the 4 components of the CAM)
- Identify 2 barriers to detecting / diagnosing delirium
- Identify the risks and benefits of using psychotropics to treat delirium symptoms
- Identify /name 2 potentially deliriogenic medications

## Sexuality in LTC Settings: How to Manage a Touchy Issue

An overview of sexuality issues related to older adults in LTC exploring sexual expression and intimacy, concerns regarding safety and attitudes of staff and family, as well as the role of effective sexuality policy in LTC. **Presenter: Melanie J. Davis, Ph.D., CSES** 

An educator and advocate for sexual education of human services professionals, Dr. Davis is the co-president of the Sexuality and Aging Consortium at Widener University. She is the co-founder of the N.J. Center for Sexual Wellness. Her interactive plenary will enrich all participants' knowledge related to this topic.

#### Participants will be able to:

- Identify three examples of how age-related sexual privilege and assumptions affect older adult sexuality
- Describe at least one new model for assessing sexual consent among cognitively impaired older adults
- List up to 4 ways that sexuality policies and staff training protect long-term care facilities, staff, residents, and residents' partners
- Apply new problem-solving knowledge to scenarios including sexual disinhibition, cognitive impairment, healthy partner rights, and intervention by residents' adult children

1) MLTSS Panel Update; Moderated by Lucille Esralew, Ph.D. NADD-CC, CDP Roxanne Kennedy, Joseph Bongiovanni and Irina Stuchinsky from DHS and representatives from Managed Care Organizations will update participants about MLTSS and its impact on behavioral health and psychiatric care of older adults in the community. During the course of her work, Ms. Mills has provided educational presentations related to public guardianship as well as the NJ Adult Protective Services program, increasing community awareness to this important topic.
