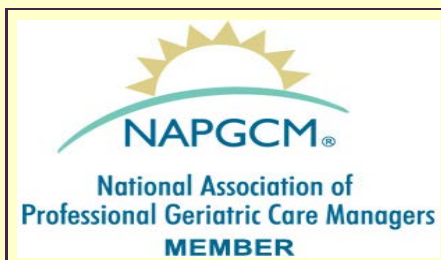
Garrett Vogel graduated from SMU and received his MBA from the University of California. His more than 30 years of experience includes work with assisted living facilities, hospitals, continuing care
