AHCA/NCAL Applauds Long-Term Care Act

The American Health Care Association and National Center for Assisted Living praises the efforts of Sen. John Thune, R-S.D., and Rep. Lee Terry, R-Neb., for introducing The Long-Term Care Act of 2007 in the Senate and House of Representatives.

The legislation would allow people to use, without penalty, pre-tax dollars from individual retirement accounts as well as other retirement savings plans to purchase qualified long-term care insurance.

Genworth Financial's 2007 Cost of Care Survey, which was released in April, found that the average national cost of long-term care had increased 15 percent since 2004 and that 75 percent of Americans have made no long-term care plans, while 59 percent expressed concern about being able to pay for long-term care.

"The staggering costs of retirement can quickly overwhelm one's savings, so it is important for the 77 million baby boomers who are rapidly approaching retirement age to prepare themselves now for their health care needs when they do retire," AHCA/NCAL President and CEO Bruce Yarwood says in a press release.

Dalpiaz Leads AAHSA's Long-Term Care Solution Project

Elaine Dalpiaz will now lead American Association of Homes and Services for the Aging's campaign to advance reforms for financing long-term care in the U.S.

In her new role, Dalpiaz will be responsible for leading the organization's effort to develop a three- to five- year plan for policy makers, opinion leaders, providers and consumers to educate and influence their thinking about the need for policy changes to meet the critical needs of America's rapidly aging population.

Dalpiaz brings to the project more than 20 years of experience addressing issues and policies critical to American seniors. Since 2005, she has worked as an independent policy and legislative consultant. She also served as professional staff for Sen. John Breaux, D-La., on the Senate Special Committee on Aging where she was primarily responsible for the issues of long-term care, healthy aging, family caregiving and the Older Americans Act. Prior to joining the committee, Dalpiaz worked for Sen. Blanche Lincoln, D-Ark., as a legislative assistant. There, she handled a variety of domestic policy affecting older adults, including Social Security, Medicare reform and prescription drug coverage.

Dalpiaz has also served as deputy director of the 1995 White House Conference on Aging, communications director for the National Senior Service Corps and as a program officer in the Administration for Children and Families at the U.S. Department of Health and Human Services. She earned a bachelor's degree in liberal arts from Walsh College in Canton, Ohio and her master's degree in social policy from the London School of Economics.

ALFA Releases Toolkit on Hospice and Assisted Living

The Assisted Living Federation of America now offers a toolkit with information on hospice services for residents of assisted living communities.

ALFA worked with the National Hospice and Palliative Care Organization (NHPCO) to develop this three-part toolkit for assisted living providers, hospice providers and consumers.

The consumer portion of the toolkit provides an overview of assisted living and hospice care, a checklist to help select an assisted living community with hospice services and a step-by-step guide to advance planning and helping a family member no longer able to make decisions. The hospice portion provides and understanding of assisted living for hospice providers and the assisted living portion provides information about hospice for assisted living providers.

The Alzheimer's Association, in collaboration with SNAP for Seniors<sup>®</sup> Inc., announces the upcoming launch of the Senior Housing Finder, the first national online dementia-specific senior housing database.

The Alzheimer's Association and SNAP for Seniors, a Seattle-based corporation which offers a free online resource with information and tools to help make informed decisions about senior housing, invite all senior housing and residential care providers to complete a free SNAP-Profile so that their detailed information will be included in search results when the search engine goes live in November 2007.

The Senior Housing Finder is an extension of the Alzheimer's Association CareFinder, which helps identify care options based on a person's needs and preferences. The addition of the Senior Housing Finder, powered by SNAP for Seniors, will provide search tools that allow users to locate professional and residential care options that match the level of care a person requires.

The housing finder functions much like a regular search engine, allowing users to search by various geographic criteria, name of residence, housing type, availability status and license type. An advanced search option will also be available, which allows users to screen for desired lifestyle amenities and care services, including the specific level of dementia care offered. In addition to the free listing, a photo gallery and availability posting

service are offered for a fee.

Consumers will be able to access Senior Housing Finder directly through the Alzheimer's Association's web site. The Alzheimer's Association's 24/7 national helpline will also direct callers to the Senior Housing Finder.
