## Legislative

The general assembly convened the second Monday of January with a few new changes led by newly elected governor Nathan deal. All sessions have their challenges but with a projected \$2 billion dollar shortfall this one proves to be exceptionally tough. The governor has released his budget and it includes a 1% cut in Medicaid reimbursement rates excluding hospitals and home and community based services. The government affairs team is meeting with budget writers to propose solutions for our portion of the cut.

January has been a relatively slow month due to the snow and ice storm and we expect it to pick

up in the coming month.

### Reimbursement Corner

2011 Medicare Part B Fee Schedules – Effective January 1, 2011 through December 31, 2011

The January 1, 2011 therapy fees for each CPT/HCPCS in each geographic area are provided in Excel format. This document has four worksheets containing the following information:

- 1. The 2011 Medicare Part B Fee Schedule (Part B Fees) for Outpatient Rehabilitation for each Carrier and Locality.
- 2. The 2011 Medicare Part B Fee Schedule (Part B Fees) for those "Always Therapy" services subject to the Multiple Procedure Payment Reduction (MPPR) Policy for Outpatient Rehabilitation for each Carrier and Locality.

- 3. The 2011 Relative Value Units (RVUs) for each Outpatient Rehabilitation Therapy Code.
- 4. The 2011 Geographic Practice Cost Indices (GPCI) by Medicare Carrier and Locality.

Please note that the fees reflect all changes included in the 2011 Medicare Physician Fee Schedule Final Rule published in the Federal Register on November 29, 2010 and corrections expected to be published in the Federal Register on January 11, 2011 (the regulation, CMS-1503-CN2, was posted on December 30, 2010). The fee schedule also reflects legislation signed by the President (the Physician Payment and Therapy Relief Act of 2010 and the Medicare and Medicaid Extenders Act of 2010) which provides for revisions to the multiple procedure payment reduction percentage and for a zero percent (0%) update to the 2011 Medicare Physician Fee Schedule through December 31, 2011. A notice will be published in the Federal Register regarding these changes..

The final rule re-established HCPCS 95992, Canalith repositioning proc, as an active code for Part B therapy services. (This code was originally established as a bundled code in CY 2009 and was not recognized for Medicare payment in CY 2010.)

Most importantly, CMS is applying a new Multiple Procedure Payment Reduction (MPPR) to the Practice Expense (PE) component of payment of select therapy services paid under the Medicare Physician Fee Schedules (MPFS). This reduction will apply when more than one unit or procedure is provided to the same patient (resident) on the same day across therapy disciplines. The reduction for SNFs will be 25% of the PE. The MPPR applies to multiple units and multiple procedures.

Full payment is made for the unit or procedure with the highest PE payment. For subsequent units and procedures furnished to the same patient on the same day, full payment is made for work and malpractice components and 75% for the PE component. This will apply to both bill types 22X and 23X.

The reduction applies to the HCPCS codes contained on the list of "always therapy" services that are paid under the MPFS, regardless of the type of provider or supplier furnishing services. The list is found in the appendix A to CR826OTN. References include MLN Matters Article #MM7050 Revised. Related Change Request (CR) # 7050. Related Transmittal # R826OTN. These have an effective date of January 2, 2011; therefore, it will impact your January 2011 billing. #### Reminder About New Medicare Timely Payment Requirement

The Centers for Medicare & Medicaid Services (CMS) is reminding Medicare Fee-For-Service physicians, providers and suppliers submitting claims to Medicare for payment that as a result of the Patient Protection and Affordable Care Act (PPACA), effective immediately, all claims for services furnished on or after Jan 1, 2010, must be filed with your Medicare contractor no later than one calendar year (12 months) from the date of service – or Medicare will deny them. In general, the start date for determining the 1-year timely filing period is the date of service or "From" date on the claim. For institutional claims that include span dates of service (i.e., a "From" and "Through" date on the claim), the "Through" date on the claim is used for determining the date of service for claims filing timeliness. For claims submitted by physicians and other suppliers that include span dates of service, the line item "From" date is used for determining the date of service for claims filing timeliness.

## **Emergency Preparedness**

#### Winter Weather FAQ's

#### What is hypothermia?

When exposed to cold temperatures, your body begins to lose heat faster than it can be produced. The result is hypothermia, or abnormally low body temperature. Body temperature that is too low affects the brain, making the vicim unable to think clearly or move well. This makes hypothermia particularly dangerous because a person may not know it is happening and won't be able to do anything about it.

Hypothermia occurs most commonly at very cold environmental temperatures, but can occur even at cool temperatures (above 40°F) if a person becomes chilled from rain, sweat, or submersion in cold water.

#### Who is most at risk for hypothermia?

Victims of hypothermia are most often:

- elderly people with inadequate food, clothing, or heating
- babies sleeping in cold bedrooms
- · children left unattended
- adults under the influence of alcohol
- · mentally ill individuals
- people who remain outdoors for long periods—the homeless, hikers, hunters, etc.

What are the warning signs for hypothermia?

#### Adults:

- · shivering/exhaustion
- · confusion/fumbling hands
- · memory loss/slurred speech
- drowsiness

#### Infants:

bright red, cold skin

very low energy

What should I do if I see someone with warning signs of hypothermia?

If you notice signs of hypothermia, take the person's temperature. If it is below 95°, the situation is an emergency—get medical attention immediately.

If medical care is not available, begin warming the person, as follows:

Get the victim into a warm room or shelter.

If the victim has on any wet clothing, remove it.

Warm the center of the body first—chest, neck, head, and groin—using an electric blanket, if available. Or use skin-to-skin contact under loose, dry layers of blankets, clothing, towels, or sheets.

Warm beverages can help increase the body temperature, but do NOT give alcoholic beverages. Do not try to give beverages to an unconscious person.

After body temperature has increased, keep the person dry and wrapped in a warm blanket, including the head and neck.

Get medical attention as soon as possible.

To meet the growing demand for training in psychological first aid, the Georgia Department of Behavioral Health and Developmental Disabilities (DBHDD) is partnering with the Georgia Department of Community Health, Division of Emergency Preparedness and Response to offer a series of one-day classes in Psychological First Aid for Nursing Homes Train-the-Trainer. This training is free of charge and is paid for with funding from Georgia's Health Community Preparedness Program. Training staff from nursing homes throughout Georgia are invited to take part in one of four train-the-trainer classes that will be held at a variety of locations throughout the

state, so be on the look-out for training announcements about these classes.

# RUG-IV delay repealed and therapy caps exceptions extended

President Obama signed into law the Medicare and Medicaid Extenders Act of 2010 (H.R. 4994), that contains the repeal of the RUG-IV implementation delay and an extension of the therapy exceptions process until December 31, 2011. AHCA/NCAL applauds both Congress and the President for addressing these critical issues before the end of the year to ensure that high quality patient care is not compromised.

Extension of exceptions process for Medicare therapy caps. Current law places annual per beneficiary payment limits for all outpatient therapy services provided by non-hospital providers. The Secretary was required to implement an exceptions process for cases in which the provision of additional therapy services was determined to be medically necessary. The provision would extend the therapy caps exception process through December 31, 2011.

Repeal of delay of RUG–IV. Under current law, implementation of Version four of the Resource Utilization Groups ("RUG IV") for purposes of reimbursing skilled nursing facilities under Medicare is delayed until October 1, 2011. The provision would repeal the delay and allow RUG IV to go into effect on October 1, 2010, consistent with the final SNF payment regulation for FY2011.

AHCA NCAL has provided a summary of the bill and the bill text . Other issues of interest to post-

acute and long term care in the law include year-long extensions of the Medicaid Qualifying Individual Program and the Medicaid Transitional Medical Assistance Program until December 31, 2011.

#### From CMS: Important Information on the Timely Claims Filing Requirement

The Centers for Medicare & Medicaid Services (CMS) would like to remind Medicare Fee-For-Service physicians, providers and suppliers submitting claims to Medicare for payment, as a result of the Patient Protection and Affordable Care Act (PPACA), effective immediately, all claims for services furnished on or after Jan 1, 2010, must be filed with your Medicare contractor no later than one calendar year (12 months) from the date of service – or Medicare will deny them. If you have Medicare Fee-For-Service claims with service dates from Oct 1, 2009, through Dec 31, 2009, those claims MUST be filed by Dec 31, 2010, or Medicare will deny them. Claims with service dates from Jan 1, 2009, to Oct 1, 2009, keep their original Dec 31, 2010 deadline for filing.

In general, the start date for determining the 1-year timely filing period is the date of service or "From" date on the claim. For institutional claims that include span dates of service (i.e., a "From" and "Through" date on the claim), the "Through" date on the claim is used for determining the date of service for claims filing timeliness. For claims submitted by physicians and other suppliers that include span dates of service, the line item "From" date is used for determining the date of service for claims filing timeliness.

#### Red Flag Rules amended by Congress

The Red Flag Program Clarification Act of 2010 (S. 3987) has now been passed by both the Senate and House and awaits signing by the President. It appears to relieve health care providers

from classification as creditors under the Red Flag Program and thus not subject to the mandated processes, procedures and enforcement connected with such classification. However, as explained in the AHCA memo, Scope of Red Flags Rule Narrowed by Congress, further clarification from the Federal Trade Commission (FTC) pertaining to health care providers may be needed. AHCA had met with the FTC and adamantly opposed the classification of skilled nursing facilities (SNFs) as creditors due to the predominance of Medicare, Medicaid and insurance as the payers for the services. We will continue to oppose such classification.

As also explained in the attached memo, please note that the first part of the rule – the Address Discrepancy Rule - appears to remain intact and still applicable to SNFs. This only applies to SNFs if facilities use certain consumer reports - for example, in connection with employment.

AHCA will leave its Identity Theft/ Red Flag Tool Kit posted on the AHCA web site until complete clarification of the remaining issues has been received and provide to our members.

F356- Nurse staffing information (data requirements; posting requirements; public access to posted nurse staffing data; facility data retention requirements).

The facility must post specified information on a daily basis at the beginning of each shift.

#### President Signs Awaited For Bill

On December 17, 2010 President Obama signed into law the Medicare and Medicaid Extenders Act of 2010 (H.R. 4994), which contains the repeal of the RUG-IV implementation delay and an extension of the therapy exceptions process until December 31, 2011. # MedPAC chairman's proposed recommendation: no SNF PPS market basket update

At the December 2nd public meeting, Medicare Payment Advisory Committee (MedPAC) staff

reviewed the adequacy of Medicare Part A payments to skilled nursing facilities (SNFs), and reported the Chairman's proposed recommendation for no market basket update for FY 2012.

Noting estimated 2009 SNF margins of 18.1 percent overall, the MedPAC Chairman raised the issue of whether MedPAC should examine and make recommendations on rebasing the SNF Medicare Part A prospective payment system (PPS) as they previously recommended for the home health PPS. A number of Commissioners appeared to be supportive of the no market basket recommendation and interested in exploring rebasing. Other Commissioners indicated that they might be open to the idea of doing more than the Chairman's proposed recommendation but that any changes should be done in the broader context of integration of payments (i.e. bundling).

In a press release, AHCA asked MedPAC to recommend to the Congress a full market basket cost of living update for SNFs. AHCA believes that the update is necessary at this time to preserve access to quality care, protect good local health care jobs, and sustain the funding stability needed for the continued quality improvements, particularly as states are under significant budgetary pressures and cuts to Medicare Part A SNF payment rates. AHCA will be following up with MedPAC in the coming weeks before they vote on their final payment recommendations for the SNF PPS.

#### Mutual Aid Compact

During the recent GHCA council meetings, your Council Coordinators introduced the Mutual Aid Compact. This agreement mirrors the agreement that is currently implemented among the GA hospitals. It says that the center agrees to assist other centers (within reason and if they are able) during an emergency situation. This document is NOT a contract, but only a disaster agreement. In addition, this agreement has been reviewed and cleared by the GHCA legal team. It is our goal to have all facilities submit the document to GHCA and your Council Coordinator by the end of the year.
