Nancy is responsible for completing the Minimum Data Set (MDS), a federally mandated process for clinical assessment of all residents in Medicare or Medicaid certified nursing homes. This process provides a comprehensive review of each resident's functional capabilities and aids in creating a plan of care based on individual resident needs. Assessments are conducted on admission then quarterly thereafter. Nancy coordinates the schedule for Care Conferences which are held shortly after completion of the MDS process. Care conferences are opportunities for the resident and their families to meet with the interdisciplinary team to review goals and plans of care. Nancy is a member of the Interdisciplinary Team.



Jean Feimster, BSW CDP

Social Worker

Jean holds a Bachelor's Degree in Social Work from the University of Michigan. She has worked with seniors and special populations for her entire career. In her role at Christian Care, she is responsible for assessing the mental health and cognitive abilities of residents and developing plans of care to assist residents and families to maintain optimal emotional and psychosocial well-being. Jean assists residents and families in navigating and accessing community mental health services, applying for state and federal financial resources and as an advocate to protect residents' legal rights. Activity Director

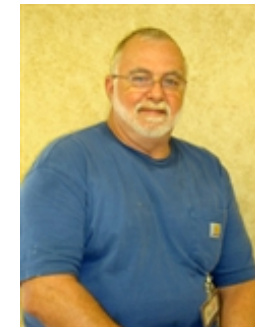
