Please don't miss this wonderful opportunity to network with peers, hear from representatives from the Division Health Service Regulation (DHSR) and network with "seasoned" leaders in the state and from across the nation. There are nearly 16,000 Certified Therapeutic Recreation Specialists in the country (about 30% of which work with the elderly population) and nearly 7,000 NCCAP certified professionals (that work with primarily the elderly). The

number of certified activity professionals will need to double before the end of 2010. CMS is taking a long hard look at the activity profession. The number of activity deficiencies nationwide with the new QIS process is on the rise. We need to step back and examine the deficiencies, and be prepared to implement person -centered programs in all facilities.

You can do your part by mentoring and educating a peer and by assisting them to understand the importance of the power in numbers. Professional credentials have never been more important for activities.

The NCCAP has announced that, beginning 1/1/2011, a national exam will be a required component for professionals pursuing initial certification with NCCAP.

The time is NOW to become nationally certified by NCCAP before the end of 2010.

Avoid the national exam! Become certified at any level this year,

AAPC, AAC, ADPC, ADC, ACC. Once you become nationally certified and maintain your certification, you can avoid the exam. Remember ADC Track 5 is still available for those of you that completed your state - approved training course

between 1991 and 2001.

In North Carolina, we have over 200 certified with NCCAP. We need to triple these numbers by the end of 2010! Professionals certified with NCCAP can do their part by educating and assisting those professionals wanting to become certified. Please feel free to bring your NCCAP applications with you to the workshop. Cindy Bradshaw will review applications that participants bring with them.
